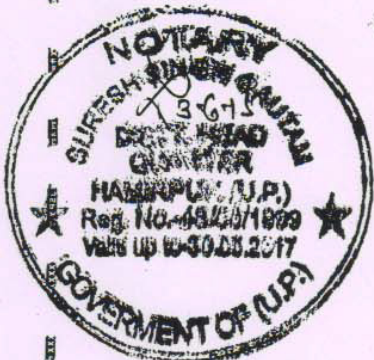
### AFFIDAVIT
